


### THOMAS F. EAGLETON SCHOLARSHIP AWARDED TO KATHERINE MURCHISON

She not only forged her way as one of the first women attorneys of color to practice law, but also led work on landmark Civil Rights cases. Ms. Freeman was part of the legal team that led the landmark civil rights case *Brewton v. Board of Education* in St. Louis. The case predated *Brown vs. Board of Education* and challenged the "separate but equal" doctrine. She also led the NAACP team that successfully ended segregation in public housing in St. Louis. For that case, she conducted discovery, wrote the briefs and argued the case before a federal judge.






