He defends clients facing local, state, federal and citizen suits alleging violations of environmental requirements, and represents clients in other environmental litigation as well.

Eric is known for his focus on Clean Air Act litigation. He has represented numerous clients in New Source review (NSR) and Prevention of Significant Deterioration (PSD) enforcement, as well as matters involving indoor air quality, new source performance standards (NSPS), national emissions standards for hazardous air pollutants (NESHAPs), risk-management plans (RMP), off-site releases, and odor and dust nuisance. He has substantial experience with EPA's air enforcement, "next generation," and environmental justice initiatives, and has assisted clients with DHS's Chemical Facility Anti-Terrorism Standards (CFATS).

Eric also has worked on significant Clean Water Act matters. He has defended industrial and governmental clients in water enforcement actions, including citizen suit challenges to real estate and highway projects. He has negotiated NPDES and pretreatment permits, and appealed water quality standards (WQS) and WQS-based effluent limits and dry and wet-weather permit requirements (including relating to combined sewer overflows (CSOs)).

Eric also has represented clients in enforcement matters involving alleged violations of the hazardous material and solid and hazardous waste requirements. Such matters have involved material characterization, generator and TSD requirements, DOT shipper requirements, PCBs, vapor intrusion, and site closure. He has also represented clients in litigation involving contaminated sites.

Eric helps to close real estate and corporate transactions in which environmental compliance and contamination issues play a role. He has assisted clients to resolve contamination concerns through insurance products, no-further remediation (NFR) letters via voluntary clean-up
