For public transit agencies, he has managed the restructuring of third-party contracts for fixed route systems to reflect an increased ability to manage and direct transit services in-house.

Tony began his career at the Federal Transit Administration (FTA). There, he was involved in the implementation and enforcement of the Title VI program under the Civil Rights Act of 1964, as amended, and the Disadvantaged Business Enterprise (DBE) program. He also served as staff attorney for the reauthorization of the federal transit program. This experience laid the groundwork for him to fully understand the needs of his clients and successfully guide them to compliance.
