### overview

Secured multiple dismissals of claims in each case after vigorous cross-examination of customers following depositions.
- In California State Court, prevailed at trial involving breach of contract and related claims for real property located in Shanghai, China, resulting in judgment in favor of the client and awarding the client hundreds of thousands of dollars in damages, including interest.
